## **Project Description**

In 2021, the Philippines was identified as the deadliest country in Asia and third in the world for environmental defenders, with women facing unique vulnerabilities and even graver threats. In the face of continued extractive human activities that have devastating environmental impacts, along with the persistent feminization of the burden of managing natural resources for a household's survival, WE-Defend (Nurturing the Indigenous Peoples and Local Communities' Women Environmental Defenders) will advance women's leadership through innovative and direct support that empowers and capacitates WEDs (Women Environmental Defenders). Through the support of the Bureau of Democracy, Human Rights and Labor (DRL), The Asia Foundation through its partners including The Samdhana Institute will implement this 16- month project to Empower Women Environmental Defenders (WED) to participate across all levels of environmental governance meaningfully and safely.

WE-Defend will employ a two – pronged approach:

- First support and advance traditional tools and support for security (including legal defense, psychosocial support, and dialogues with the security sector)
- Second socialize environmental defense into a broader movement with a view towards depoliticizing the work of WEDs in the frontlines.

#### Objectives:

- Equip WEDs (Women Environmental Defenders) and civil society organizations (CSOs) with the necessary skills to conduct their work safely and effectively and influence policies without threats of violence.
- Advance women's leadership and advocacy on local and national priorities related to natural resources and the environment.

- Small Grants Program Cohort and Fellowship Program
  - O WE-D Cohort Program
    - A micro grant for the WEDs to implement or initate their own community projects
  - O WE-D Fellowship Program
    - **Current Leaders** 
      - Five (5) Fellows who have ongoing engagement or involvement in environmental defense and have been working with the community for five years or less
    - **Emerging Leaders**

Ten (10) community leaders with a least two (2) years of experience and will be provided a support for the Internship program to further develop their skills/ expertise
